## **CALIFORNIA LEGISLATION**

## AB 538 - Chaptered October 11, 2025

Requires awarding bodies to obtain certified payroll records from relevant contractors and make them available to the requesting entity. Authorizes the Division of Labor Standards Enforcement to enforce certain penalties if a contractor fails to comply with the awarding body's request within 10 days of receipt of the notice.

## AB 1121 - Chaptered October 8, 2023

Requires California Awarding agencies to annually submit to the Department of Industrial Relations' a list of ineligible contractors, pursuant to local debarment or suspension processes.
